ORDINANCE No. 618-02

TO AMEND THE CODE OF THE MUNICIPALITY OF MURRYSVILLE, CHAPTER 210, THEREOF, ENTITLED VEHICLES AND TRAFFIC AS FOLLOWS:

WHEREAS, the Municipality of Murrysville recognizes the need for standardization throughout the nation in criteria for erecting traffic control signs which are set forth in the Pennsylvania “Vehicle Code”; and

WHEREAS, the Municipality of Murrysville also recognizes the paramount duty to do all in its power to protect the public safety of its residents;

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Council of the Municipality of Murrysville, Westmoreland County, Commonwealth of Pennsylvania, and it is hereby ORDAINED AND ENACTED by the authority of the same.
