ORDINANCE NO. 620-02**

**AN ORDINANCE AMENDING THE COMPENSATION OF THE EMPLOYEES OF THE  
HOME RULE MUNICIPALITY OF MURRYSVILLE, PENNSYLVANIA FOR FISCAL YEAR  
2003**

**WHEREAS**, the Municipality of Murrysville has enacted an ordinance establishing the compensation and authorized number of employees in the classification of employment for the municipal government; and

**WHEREAS**, it is the desire of the Council of the Municipality of Murrysville to established ranges for various job classes and positions in accordance with the Home Rule Charter;

**WHEREAS**, it is the desire of the Council of the Municipality of Murrysville that new employees shall not be paid below the minimum of their appropriate grade;

**NOW, THEREFORE, BE IT ORDAINED AND ENACTED** and it is hereby ordained and enacted by Council of the Municipality of Murrysville, pursuant to the authority of the same, the following amended salary ranges shall be adopted:
